## Job Summary:

The Summer Sub Days Campaign Influencer is responsible for acting as a brand ambassador and social media influencer to increase sales and social awareness of our Summer Sub Days campaign through the use of user-generated content on Instagram.

The Digital Marketing & Advertising Manager will provide a content calendar to inform the Influencer what the product focus, talking points, and basket increase items will be for each week. For example: Week 1 (5/20 – 5/26) post will be focused on the Classic Italian Sub and must include a 20oz Pepsi in the image with appropriate hashtags.

Influencers will be broken down into two groups for alternating content calendars to ensure the message is spread across groups and categories.

#### Responsibilities/Requirements:

- 1. Must be following QuickChek on Instagram and allow QuickChek to follow back
- 2. Must have a cell phone with reliable access to Instagram for entirety of program
- 3. Must have 1,000+ Instagram followers
- 4. Cannot have politically incorrect or brand-damaging posts with content including:
  - a. Cursing
  - b. Political
  - c. Nudity
  - d. Competitor products
  - e. Anti-QuickChek posts
  - f. Negative comments about Team Members
  - g. Other potentially damaging content as decided by the Digital Marketing & Advertising Manager



- 5. Must be currently active on Instagram with a strong understanding of currently trending content (#hashtags, photo styles, use of stories, adding gifs, posting polls, engaging content)
- 6. Able to provide cell phone number and e-mail address to Digital Marketing & Advertising Manager for texting/distributing content plans
- 7. Must be a current QuickChek Team Member store or Support Center
- 8. Must have approval from current leader

## Compensation/Incentives:

- 1. At the completion of the Summer Sub Days Campaign, the Influencer will be compensated wages in the 9/9/2019 pay period.
- 2. The Influencer will be provided with vendor-funded items (like movie tickets, branded vendor swag, amusement park tickets, production plant tours, etc.) that will be determined at a later date.
- 3. The Influencer will be provided with \$25 QuickChek Gift Cards to purchase the product(s) for the photos.
- 4. Top three Influencers per month will be rewarded with a \$50 Visa Gift Card. Top posts will be determined by use of specific hashtag and the number of likes/comments.
